Rental Booking Conditions

- 1. The property known as *Blue Shutters*, *Beaufort* located at No. 1 Rue des Petits Cartables, 34210 Beaufort, (Languedoc) France is offered for vacation rental, subject to confirmation, by the owner **Chris Allicock**, to the renter (*the client*).
- 2. To reserve *Blue Shutters Beaufort*, the client should complete and sign the booking form, then return it with payment of the non-refundable deposit (200 Euros). **Upon receiving the completed booking form and deposit, the owner will send a receipt. This receipt will be a formal acceptance of booking.**
- 3. The balance of the rent, together with the security deposit (see Clause 4), is payable not less than eight weeks before the start of the rental period. If payment is not received by the due date, the owner reserves the right to give notice in writing that the reservation is cancelled. The client will remain liable to pay the balance of the rent unless the owner is able to re-let the property. In this event, Clause 5 of the booking conditions will apply. Reservations made within eight weeks of the start of the rental period require full payment at the time of booking.
- 4. Any chargeable expenses arising during the rental period should be settled with the owner before departure.
- 1. A security deposit of \$200.00 Euros (or Cdn. or American Equivalent) per rental period is required in case of, for example, damage to the property or its contents.
- 2. However, the sum reserved by this clause shall not limit the clients' liability to the owner. The owner will account to the client for the security deposit and refund the balance due within two weeks after the end of the rental period.
- 5. Subject to Clauses 2 and 3 above, in the event of cancellation, refunds or amounts paid will be made if the owner is able to re-let the property and any expenses or losses incurred in so doing will be deducted from the refundable amount. The client is strongly recommended to

arrange a comprehensive travel insurance policy (including cancellation covereage) and to have full cover for the party's personal belongings, public liability, etc. since these are *NOT* covered by the owner's insurance.

- 6. The rental period shall commence at 4pm on the first day and finish at 10am on the last day. The owner shall not be obliged to offer the accommodation before the time stated and the client shall not be entitled to remain in occupation after the time stated.
- 7. The maximum number to reside in the property must not exceed 4, unless the owner has given written permission.
- 8. Although the cleaning of the unit is included in the rental fee, the owner reserves the right to retain a portion of the security deposit to cover additional cleaning costs if the client leaves the property in an unacceptable condition
- 9. The client agrees not to act in any way that would disturb residents in neighbouring properties.
- 10. The client shall report to the owner, without delay, any defects in the property or breakdown in the equipment, plant, machinery or appliances in the property.
- 11. The owner shall not be liable to the client:
- a. For any temporary defect or stoppage in the supply of public services to the property or to any equipment or appliance in the property.
- b. For any loss, damage or injury, which is a result of adverse weather, conditions, nor war, strikes or other matters beyond the control of the owner.
- c. For any loss, damage or inconvenience caused to or suffered by the client if the property shall be destroyed or substantially damaged before the start of the rental period and, any such event, the owner shall, within seven days of notification to the client, refund all sums previously paid in respect of the rental period. Under no circumstances shall the owner's liability to the client exceed the amount paid to the owner for the rental period.
- 13. The client agrees to respect the owner's request that there be no smoking in the house.
